CALIFORNIA EVAPORATIVE EMISSIONS CONTROL SYSTEM WARRANTY STATEMENT

YOUR WARRANTY RIGHTS AND OBLIGATIONS

The California Air Resources Board and Highfield are pleased to explain the evaporative emission control system's warranty on your 2023 watercraft. In California, new spark-ignition marine watercraft (SIMW – PHFMPVSNTR1 & PHFMPVSSLTR1) must be designed, built, and equipped to meet the State's stringent anti-smog standards. Highfield must warrant the evaporative emission control system on your watercraft for the period listed below provided there has been no abuse, neglect or improper maintenance of your SIMW.

Your evaporative emissions control system may include parts such as: canisters, carburetors, clamps, connectors, filters, fuel caps, fuel lines, fuel tanks, valves, vapor hoses, and other associated evaporative emissions control system components.

MANUFACTURER'S WARRANTY COVERAGE:

This evaporative emission control system is warranted for two years. If any evaporative emission-related part on your SIMW is defective, the part will be repaired or replaced by Highfield.

OWNER'S WARRANTY RESPONSIBILITIES:

(7) Control Solenoids*

- As the watercraft owner, you are responsible for performance of the required maintenance listed in your owner's manual. Highfield recommends that you retain all receipts covering maintenance on your watercraft, but Highfield cannot deny warranty solely for the lack of receipts.
- As the watercraft owner, you should however be aware that Highfield may deny you warranty coverage if your spark-ignition marine watercraft or a part has failed due to abuse, neglect, or improper maintenance or unapproved modifications.
- You are responsible for presenting your watercraft to a Highfield distribution center or service center as soon as the problem exists. The warranty repairs should be completed in a reasonable amount of time, not to exceed 30 days.
